OR

- You want your case to be heard and decided by a jury of six (6) citizens of the county rather than by the Judge.

In either case, you must pay a \$70.00 fee to transfer the case to the Plenary Docket.

“Verified” means that by signing and submitting this Motion, you swear or affirm under oath and under penalties for perjury that all the answers and information are true and accurate.

→ You must complete only the top half of the Order.

Comes now Defendant, and requests this claim and any accompanying Counterclaims or Third party Claims be;

Transferred to the Plenary Docket in Superior Court No. 4 as the amount of my Counterclaim or Third Party Claim exceeds the Small Claims jurisdictional limit of \$6000.00 (but I am not requesting a jury trial in this case).

Scheduled for a trial by jury pursuant to Small Claims Rule 4(C) and thus transferred to the Plenary Docket in Superior Court No.4.

I understand that:

1. This Motion must be filed within ten (10) days after I was served the Plaintiff's Notice of Claim. If I do not file this request on time, I understand this request will be denied and I will not be allowed to renew or file this Motion again.
2. I must pay the Clerk a fee of \$70.00 to transfer this claim and any accompanying Counterclaims or Third Party claims to the Plenary Docket if my Motion is granted.
3. If I later decided to withdraw my Request to Transfer to the Plenary Docket, I understand the \$70.00 transfer fee will not be refunded to me. If I later want to withdraw my Request for Jury Trial, I can only do this with the consent of the Plaintiff. Again, I understand the \$70.00 transfer fee will not be refunded to me.
4. Once this claim and any accompanying Counterclaims or Third party Claims are transferred to the Plenary Docket in Superior Court No. 4 (whether for bench trial or for jury trial), the case will lose its status as a Small Claims case and the less formal Small Claims Rules will no longer apply. I understand the Plenary Docket requires strict following of all statutes, laws, trial rules and rules of evidence. While I may still represent myself in a Plenary Docket case, I acknowledge the Court does not recommend that I do so as the Court cannot give me any special consideration or help because I am not an attorney. I understand the Court recommends I hire an attorney.

I swear or affirm under penalties for perjury, as specified in I.C. 35-44-2-1, the information herein is true and accurate to the best of my knowledge and belief and that on the date this Motion was filed, I served a copy of this Motion on the Plaintiff by:
