

**Oversized Moving Permit
Requirements**

Certificate of Insurance: \$500,000 General Liability from the Moving Company.
Certificate Holder: Tippecanoe County Board
of Commissioners.

Map of Route: Origin to destination.

Map of Alternate Route: Need a map of an alternate route onto county roads in case of a break
down on State Roads.

Letter from Sheriff: Letter stating Sheriff's Department assistance with traffic
control.

Contact Utilities: It is the owner/movers responsibility to notify all utilities along the route.

Drive: Need to also apply for an existing drive or a drive permit if home is **not** going into a mobile
home park or out of Tippecanoe County.

Fee: \$75.00, Checks made payable to the Tippecanoe County Treasurer.

GRANT OF PERMIT TO TRANSPORT OVERSIZED VEHICLES & OBJECTS OVER COUNTY ROADS

The Tippecanoe County Highway Engineer hereby grants to _____,

A permit to transport oversized vehicles and objects over Road(s) _____

_____ as described in the Application for Permit to Transport Oversize Vehicles and

Objects over County Roads.

Permittee shall take all necessary precautions to assure a smooth, safe moving operation.

Permittee shall provide all necessary barricades, flagmen and warning signs, and shall see that traffic is not delayed any longer than is necessary to complete this move. All moving operations are to take place between the hours of 9:00 A.M. and 3:00 P.M. This permit does not permit movement at night or on the weekend. In addition to a lead car, a follow-up car shall be used, when requested. Both vehicles shall be equipped with flashers. A uniformed policeman, when requested, shall be positioned ahead of the moving vehicle at cross-roads and other passing points, to detain or detour traffic until after the moving vehicle has passed. In no case, will the detention of traffic for more than 15 minutes, or for an accumulation of more than 5 vehicles be permitted.

It is also understood and agreed to that the Permittee is liable for any and all damages that occur to the highways, as well as other personal and/or property damage that occurs in connection with this movement. If damage occurs, Permittee shall repair same to a condition satisfactory to the County Highway Engineer and the County Highway Supervisor. Permittee shall carry adequate insurance (personal liability and property damage) to cover any loss or damage which may occur as a result of this moving operation.

Permittee shall, at their own expense, notify all utilities affected by this moving operation and pay for all necessary relocation of the utilities services.

No trees are to be trimmed or cut to permit passage, without first receiving permission from the property owner and the Tippecanoe County Highway Department.

Permittee shall notify all emergency type operations, such as: Fire Department, Sheriff's Department, State Police, etc., informing them of said moving operation and the period of time which specific roads will be closed to their services.

If the above mentioned moving operation is not completed on or before _____, this permit shall be of no further force and effect.

The terms of this permit shall be considered as supplementary to other laws and regulations which apply to the type and class of move involved. In no case, will the start of any move be permitted until all of the necessary permits have been acquired and the provisions have been made to comply with all the applicable laws and regulations.

This permit will become effective when signed by a responsible member of the firm engaged in the moving operation and approved by the Tippecanoe County Highway Engineer.

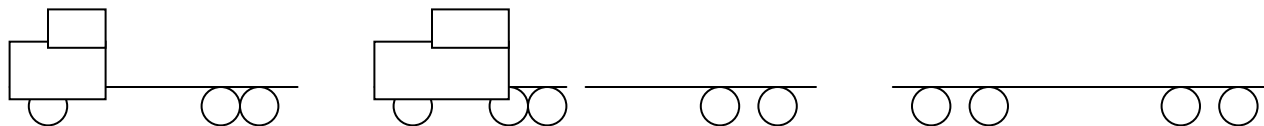
