

**ORDINANCE NO. 2009-21-CM**  
**AMENDING TIPPECANOE COUNTY CODE**  
**CHAPTER 72, SCHEDULE I**  
**Traffic Schedule regarding Speed Limits**

**WHEREAS**, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the regulatory signs, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices; and

**WHEREAS**, The Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits of the Tippecanoe County Code of Ordinances to incorporate and include the following speed limits, and to readopt Chapter 72, Schedule I as so amended:

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of Tippecanoe County, Indiana, that:

1. The Tippecanoe County Code Chapter 72, Schedule I Traffic Schedule regarding Speed Limits, be amended to delete the following and re-adopted as so amended:

| Road/Street  | Location                   | Speed limit (m.p.h.) | Temp speed (m.p.h.) | Ord.       | Date     |
|--------------|----------------------------|----------------------|---------------------|------------|----------|
| Newman Road  | From Division Road to SR26 | 30                   | NA                  | 2008-21-CM | 11-17-08 |
| CR 200 North | From SR 25 to CR 400 East  | 25                   | NA                  | 2008-21-CM | 11-17-08 |

2. The Tippecanoe County Code Chapter 72, Schedule I Traffic Schedule regarding Speed Limits, be amended to include the following and re-adopted as so amended:

| CR 250 North     | From CR 400 W to Klondike Road                | 40                   | NA                  | 2009-21-CM | 1-21-10 |
| CR 300 West      | From South River Rd to Division Rd            | 45                   | NA                  | 2009-21-CM | 1-21-10 |
| Newman Road      | From Division Road to SR 26                   | 40                   | NA                  | 2009-21-CM | 1-21-10 |
| Sharon Chapel Rd | From Newman Road to SR 26                     | 40                   | NA                  | 2009-21-CM | 1-21-10 |
| CR 450 South     | From CR250E to 0.920 miles east of CR 250 E   | 45                   | NA                  | 2009-21-CM | 1-21-10 |
| CR 450 South     | From 0.920 miles east of CR250E to CR 450 E   | 50                   | NA                  | 2009-21-CM | 1-21-10 |
| CR 200 North     | From Schuyler Ave to 0.100 miles west of I-65 | 35                   | NA                  | 2009-21-CM | 1-21-10 |
| CR 200 North     | From 0.100 miles west of I-65 to CR 400 E     | 25                   | NA                  | 2009-21-CM | 1-21-10 |

3. That in all other respects, the Tippecanoe County Code Chapter 72, Schedule I Speed Limits be, and they are hereby ratified and confirmed and shall remain in full force and effect.

4. That all signs within Tippecanoe County that function to provide regulations, warnings and guidance information for road users, in both words and symbols, within the right-of-way of all types of highways open to the public shall conform to the latest edition of the Indiana Manual on Uniform Traffic Control Devices.

5. The Sheriff's Department shall be notified of all the above traffic schedule amendments and installation of related regulatory signs.


6. The effective date of this ordinance shall be January 21, 2009.
