Commissioners present: President Tracy A. Brown, Vice President Thomas P. Murtaugh, and Member David S. Byers.

I. PLEDGE OF ALLEGIANCE

President Brown called the meeting to order and led the Pledge of Allegiance.

II. APPROVAL OF MINUTES from the Monday, December 4, 2017 Township Relief Appeal

III. PRESENTATION OF ACCOUNTS PAYABLE VOUCHERS AND PAYROLL - PAULA BENNETT
