

**TIPPECANOE COUNTY COUNCIL MEETING
COUNTY OFFICE BUILDING – TIPPECANOE ROOM
TUESDAY, MAY 09, 2017
8:30 A.M.**

The Tippecanoe County Council met Tuesday, May 9, 2017 in the Tippecanoe Room of the County Office Building at 8:30 a.m. Councilmembers present were President John Basham, Vice President Bryan Metzger, Roland Winger, Kathy Vernon, Kevin Underwood, David R Williams, and Vicki Burch. Others present were Auditor Robert A. Plantenga, Attorney Doug Masson, and Recording Secretary Caitlin Thomas.

Pledge of Allegiance

President Basham called the meeting to order and led the Pledge of Allegiance.

Auditor's Financial

Auditor Plantenga reported the COIT has now been transferred into the General Fund. He stated the county began 2017 with a General Fund cash balance of \$8,632,700.77. With projected misc. revenue, property taxes, and deducting circuit breaker credits the total available is \$53,404,949.77. The beginning net balance is \$1,321,654.77. We have approved additional appropriations of \$46,632 so far this year and there are \$33,326 to review today. Deducting the misc. revenues and the budget reductions, the total available is \$1,280,871.77.

We should be at about 33% when you look at income from permits. Line 0761 cash balance is almost completely from the COIT transfer. This will be reflected in the General Fund cash balance. In 1121 now has an ending balance of \$0. Between Funds 2580 & 2581, we are regularly using 2581 for payroll and other items. April was a good month for that fund with \$19,000 in receipts and \$11,000 in expenditures. This fund did benefit from participants spending some income tax return money. Fund 7478 contains money from the past that was collected by the clerk's office. That fund is now up to \$83,000 and we will need to do something with it. The amount of money moved from the Rainy Day Fund and has not been paid back yet is \$97,000 in Court Services, \$37,000 in Violence and Community Fund and \$59,000 in Substance Abuse. Fund 4710 is the Health Insurance Fund and it now has a cash balance of \$2.1 million dollars.

Treasurer's Report

Auditor Plantenga stated Treasurer Weston requested he give the report at today's meeting due to property tax deadline day being tomorrow. The Lafayette Bank and Trust Flex Benefits account is new and it is the first time we have had that as an interest bearing account. We have picked up a little bit of property tax money. He pointed out that Treasurer Weston has added a page to her report showing year over year comparison of interest earned amounts.

Public Comment (Agenda Items)

Judge Williams stated he wanted to make sure the Council knew they would be coming before them later to ask for money to pay for jury services. As of today, they have had nine jury trials in their courts. They have already spent over \$15,000 this year and their budget is only \$20,000. There is a civil trial coming up that is expected to run 5 weeks and could cost the county \$10,000 in jury expenses. Councilmember Winger asked when they might expect the request. Judge Williams stated it would probably be next month. Councilmember Winger pointed out we do not have the jury pay fund to fall back on because it is almost depleted. Auditor Plantenga stated the fund has built up a little bit, but if we use it here, we cannot rely on it at budget time.

Compliance with Statement of Benefits

Wildcat Creek Partners, LLC (CF-1/Real Property)

John Lutree with Wildcat Creek Partners, LLC stated they own the property at 4775 Dale Dr. That property now houses Ludo Fact USA. The controlling interest of the company was bought out last May and this is significantly changing the focus of the company. They just put in the last piece of specialty equipment, which arrived last week. Some parts were being made in Germany, but with the additional equipment, they will be able to start making them here. They estimate their employment will be significantly higher next year. He explained the toy and game industry used to be considered a risky business, but the use of Kickstarter for fund raising levels out the risks. With that resource, they are seeing a lot more small game inventors coming to them to manufacture their games.

- Councilmember Winger moved to approve the statement as presented, second by Councilmember Burch. Motion carried

Apex Warehouse and Logistics LLC (CF-1/Real Property)

A company representative stated their salaries are now up to about a million. They have either retained or slightly added to their number so they are still looking good. The surrounding area is growing at a good clip and the company is receiving lots of calls regarding employment. Attorney Masson said both statements could be approved together.

- Councilmember Winger moved to approve both of the Apex Warehouse and Logistics statements, second by Councilmember Burch. Motion carried.

Jennifer Prange stated they had a two day trial last year with an attorney who was not contracted and they rolled that bill over to the first of this year which depleted their balance in that fund. Councilmember Winger said the Judge is estimating about \$10,000 for pauper council and they recommend the appropriation be approved.

Commissioner FYI



Public Comment



Councilmember Burch moved to adjourn, second by Councilmember Winger. President Basham adjourned the meeting at 9:13 a.m.






