

TIPPECANOE COUNTY COUNCIL
REGULAR MEETING
May 12, 2009

The Tippecanoe County Council met at 8:30 a.m. on May 12, 2009 in the Tippecanoe Room in the County Office Building. Council members present were: President Kevin Underwood, Vice-President Andrew S. Gutwein, Jeffrey R. Kemper, John R. Basham II, Roland K. Winger, Betty J. Michael and Kathy Vernon. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

Councilmember Underwood called the meeting to order and led the Pledge of Allegiance.

APPROVAL OF MINUTES

- Councilmember Kemper moved to approve the minutes from the April 14, 2009 regular meeting, second by Councilmember Michael; motion carried.

AUDITOR'S FINANCIAL REPORT – Jennifer Weston

Auditor Weston reported miscellaneous expenditures were around \$20,000 last month; after researching those amounts it was determined expenditures were \$608. May 1st, 2009 was the last due date for the installment plan for property taxes. The Treasurer turned over approximately \$488,000 which will be distributed this week to the units.

TREASURER'S REPORT – Bob Plantenga

Treasurer Bob Plantenga reported the average interest rate dipped from .48% to .747%. The Cumulative Bridge CD will be due this month; \$40,000 of interest will be deposited from the CD into the local road and street account. He explained First Financial has made a proposal to the county to assist in the collection of property taxes. First Financial located on the corner of Concord Road and 350 South will collect taxes and provide a report to the county weekly with payment information. Treasurer Plantenga added First Financial will take payments from any taxpayer and provide receipts.

PRESENTATION OF PRESIDENTIAL AWARDS FOR VOLUNTEERS – Sheriff Brown

Sheriff Brown honored nine members of the Volunteer in Police Service (VIPS) program. The volunteer program was introduced nationally by President George Bush after the September 11, 2001 terrorist attacks as a way for citizens to help out local emergency responders and public safety agencies. Sheriff Brown explained the VIPS program allows the Sheriff's Department to stretch its resources with no cost to the taxpayers. The program started locally in 2006 and has put in more than 2,000 hours of service saving taxpayers \$35,000. These volunteers assist with clerical duties, traffic control, school safety checks, and attend neighborhood watch group meetings. Another component of the VIPS program is the Sheriff's Auxiliary program which has volunteers on the street assisting with night watch for schools and businesses, traffic direction, and neighborhood watch programs. Also created was the Chaplaincy Program which provides counseling services for Sheriff's Department personnel and assistance in

interacting with the public. The Sheriff thanked staff members Capt. Denise Saxton and Sgt. Doug Caldwell for their assistance with the volunteer program. Volunteer members honored were:

Councilmember Gutwein reported Judge Busch did indicate his interest in reinstating a Court Reporter position the court had in the past but lost funding. He suggested the judge was requesting part-time to carry the court through the year. Councilmember Kemper stated he would like additional information regarding the request.

- Judge Williams entered the meeting after the motion to table the additional appropriation request. He reported between the three upper courts additional staff is desperately needed to maintain the current workload. Between the three court reporters covering the courts, the current staff is struggling to keep up and unable to use paid leave without additional help.

Councilmember Kemper stated he would still like to meet with the other judges to discuss the option of job sharing possibly with the clerk’s office.

Attorney Cindy Garwood requested approval of an additional appropriation for alternative dispute resolution services for the courts. These funds are from a grant received from the Supreme Court for \$40,000 to expand mediation services and additional work for the IV-D Court.

PUBLIC DEFENDER – Amy Hutchison

Public Defender Amy Hutchison requested approval of a salary statement for a full-time Deputy Public Defender. She received approval from the commissioners for a full-time position in place of two regular part-time positions. A reported \$40,000 will be saved by combining the position into one full-time position.

Chief Probation Officer Kipp Scott requested approval of a salary statement for part-time. With the loss of a full-time Probation Officer, additional help is needed to maintain the case log. Treasurer Bob Plantenga requested a transfer to purchase forms for tax bills. He explained tax bills were previously printed and mailed by an outside vendor; bills will now be printed in house allowing the county to mail multiple bills in one mailing to save the county money.

Human Resource Coordinator Shirley Mennen explained a large portion of the funds being requested by the assessor are to cover unemployment cost for employees whose positions were eliminated by House Bill 10.01. Auditor Weston stated the requested amount is anticipated through the end of the year. Councilmember Kemper requested the County Assessor provide a breakdown of the employees and the amount paid for the year.

Councilmember Kemper reported the Youth Center Action Team met and discussed possible locations for the new Probation/Intake Officers for Juvenile Probation. The team has met several times and concluded to move forward with a small expansion of space for office use at the jail. If funding is approved by the council, the office may be up and running by the fall. He anticipates updating the council at their next meeting.

Councilmember Basham stated he will spend more time in the assessor's office to better understand the process to assist both the office and the council with additional information.

UNFINISHED/NEW BUSINESS


Commissioner Byers stated the commissioners have received a proposal regarding the use of the fairgrounds and have also discussed several options for generating revenue funds.

PUBLIC COMMENT



- Councilmember Kemper moved to adjourn.


