

TIPPECANOE COUNTY COUNCIL
REGULAR MEETING
May 13, 2008

The Tippecanoe County Council met at 2:00 p.m. Tuesday, May 13, 2008 in the Tippecanoe Room in the County Office Building. Council members present were: President Thomas P. Murtaugh, Vice President Kevin Underwood, Jeffrey A. Kemper, Betty J. Michael, David S. Byers, Kathy Vernon and Andrew S. Gutwein. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

President Murtaugh called the meeting to order and led the Pledge of Allegiance.

APPROVAL OF MINUTES

Human Resource Director Shirley Mennen reported on the County Self Insurance Fund 310. She reported the county had a few months where the Specific and Aggregate Stop-Loss amounts were exceeded. Gayle Byers, Employee Benefit Consultant with RE Sutton & Associates, will attend the June meeting to discuss planning options for the Specific and Aggregate Stop-Loss.

TREASURER'S INTEREST REPORT – Bob Plantenga

Treasurer Plantenga reported the average interest rate is 2.3%. The Homestead Credit Rebate Fund 717 continues to carry a balance due to unclaimed checks. The Treasurer's Office had a press release requesting taxpayer's pre-pay taxes for 2008. Pre-payments will allow the county to make a partial distribution to local entities. He reported approximately \$4 million has been collected to date in advance payments for property taxes.

YOUTH SERVICES UPDATE - Rebecca Humphrey

The Juvenile Justice Center Phase II Assessments are scheduled to begin within 2 weeks on the Duncan Road property. DLZ Architects, Mike McMillan, commissioners and key stakeholders are meeting to discuss preliminary designs of the facility. A presentation will be held May 19, 2008 at 10:00 a.m. at the commissioner's regular meeting.

Director Humphrey reported the youth level of service case management inventory which places youth in the right services at the right time is underway. Approximately 200 assessments have been completed for youth in probation, Juvenile Alternatives, and Cary Home in the past 2 ½ months.

Cary Home for Girls has state approval from Homeland Security and the State Department of Health. Director Humphrey is awaiting inspections by the Fire Marshall, Health Inspector and the Tippecanoe County Building Inspector.

The Cary Home End of School party will be May 28, 2008, from 4-6 p.m.


PUBLIC COMMENT

Shirley Mennen thanked the Council for her and other staff members to participate in the Government Leadership Program.


