

**INTER-GOVERNMENTAL AGREEMENT**  
**Between**  
**TIPPECANOE COUNTY AND THE CITY OF WEST LAFAYETTE**  
Regarding Reconstruction of Lindberg Road

**WHEREAS**, Tippecanoe County and the City of West Lafayette have determined the need to reconstruct Lindberg Road between Klondike Road and US 231; and

**WHEREAS**, Indiana law allows and encourages cooperation between units of government and taxpayers for the mutual benefit of all parties; and

**WHEREAS**, the Indiana Code authorizes Counties and City to take certain cooperative actions to encourage economic development; and

**WHEREAS**, Indiana Code 36-1-7, 36-1-3, 36-5-2-9, 36-9-2-5, and 36-9-2-16, authorize and empower Counties and Cities to enter into contracts to provide for the mutual benefit of the citizens of each unit of government.

**THIS AGREEMENT**, entered into on the last date signed below, by and between Tippecanoe County (hereinafter referred to as "County"), and the City of West Lafayette (hereinafter referred to as "City") seeks to accomplish the above goals.

**NOW BE IT THEREFORE AGREED** as follows in consideration of the mutual promises hereinafter set forth:

1. The parties will work together to expedite the reconstruction of Lindberg Road.
2. The City will pay one-third (1/3) of design, construction, and inspection costs. This is based on two-thirds (2/3) of the Project being located within the City and the City paying fifty percent (50%) of such costs. In addition, the City will pay costs attributable to right-of-way, utility, and railroad expenses within its jurisdiction.
3. The County will perform all bidding, contracting, administration, and supervision of this contract.
4. Attached as Exhibit A is a Cost Share Summary illustrating the costs to be paid by the City. Final billing will be based on actual costs but will not exceed nine hundred eighteen thousand, one hundred twenty and 00/100 dollars (\$918,120).
5. City will pay County according to the following schedule:  
\$114,764.98 on or before one year after letting of bids for construction.  
\$267,784.94 on or before two years after letting of bids for construction.  
\$267,784.94 on or before three years after letting of bids for construction.  
\$267,784.94 on or before four years after letting of bids for construction
6. All of the parties agree to comply with all the applicable laws of the State of Indiana.
