

**TIPPECANOE COUNTY
INDIANA DEPARTMENT OF CORRECTIONS
ADDENDUM TO GRANT ADMINISTRATION AGREEMENT**

THIS ADDENDUM TO GRANT AGREEMENT is entered into this 4th day of August, 2021, by and between the **County of Tippecanoe, State of Indiana** (hereinafter referred to as the "County"), by and through its Board of Commissioners, and **Amber Gibson**, (hereinafter referred to as the "Contractor") and amends a certain Grant Administration Agreement entered into by the parties on March 1, 2021, ("Agreement");

WHEREAS, Section 4 of the Agreement provides for amendment of the Agreement in writing; and

WHEREAS, the Parties wish to extend the term to June 30, 2022; and

WHEREAS, the Parties wish to provide that, for the period beginning July 1, 2021, and ending June 30, 2022, Contractor will provide up to twenty-four (24) yoga sessions for at-risk youth at the rate of twenty-five dollars (\$25) per session for an amount not to exceed six hundred dollars (\$600);


NOW, THEREFORE, the County and the Contractor do mutually agree as follows:

1. Section 2 of the Agreement shall be amended to provide that "For the fiscal grant year 2021-2022, the Contractor shall facilitate not more than twenty-four (24) yoga instruction class sessions to at-risk youths."
2. Section 3 of the Agreement shall be amended to provide that the term of the Agreement shall end on June 30, 2022.
3. Section 7 of the Agreement shall be amended to provide that, for the fiscal grant year 2021-2022, Contractor shall be compensated at the rate of twenty-five dollars (\$25) per class for a maximum of twenty-four (24) classes and total compensation not to exceed six hundred dollars (\$600).

In all other respects, the Agreement shall remain in full force and effect.





THIS ADDENDUM TO GRANT AGREEMENT is entered into this 16th day of August, 2021, by and between the **County of Tippecanoe, State of Indiana** (hereinafter referred to as the "County"), by and through its Board of Commissioners, and **Laura Stull**, (hereinafter referred to as the "Contractor") and amends a certain Grant Administration Agreement entered into by the parties on October 19, 2021, ("Agreement");

WHEREAS, Section 4 of the Agreement provides for amendment of the Agreement in writing; and

WHEREAS, the Parties wish to extend the term to June 30, 2022; and

WHEREAS, the Parties wish to provide that, for the period beginning July 1, 2021, and ending June 30, 2022, Contractor will facilitate up to four (4) Parenting the Teen Brain sessions at the rate of five hundred (\$500) per session for an amount not to exceed two thousand dollars (\$2,000);


NOW, THEREFORE, the County and the Contractor do mutually agree as follows:

1. Section 3 of the Agreement shall be amended to provide that the term of the Agreement shall end on June 30, 2022.
2. Section 7 of the Agreement shall be amended to provide that, for the fiscal grant year 2021-2022, Contractor shall be compensated at the rate of five hundred dollars (\$500) per session for a maximum of four (4) sessions and total compensation not to exceed two thousand dollars (\$2,000).

In all other respects, the Agreement shall remain in full force and effect.




