## MONTHLY SUMMARY

The Tippecanoe County Coroner's Office (TCCOR) intends for this information in this report to be useful to community leaders and the public at large. The data presented within this report represents the deaths occurring within Tippecanoe County, for which the TCCOR has jurisdiction. This data does not represent all deaths that occur within Tippecanoe County, nor does it reflect all deaths of Tippecanoe County residents. The decedent's place of residence or location of incident may be outside of Tippecanoe County.

### Our Values:

**INTEGRITY.** The TCCOR shows integrity through an office culture founded on pride and peer accountability, where members will maintain the highest of ethical standards.

The office of the Tippecanoe County Coroner has a dual role: **PUBLIC SAFETY AND PUBLIC HEALTH.**

As a **PUBLIC SAFETY AGENCY**, the TCCOR conducts death investigations in an independent manner and without bias. TCCOR investigators, forensic and medicolegal, work with all law enforcement agencies to gather useful information in order to determine and accurate cause and manner of death. The TCCOR investigators also ensure legal positive identification of decedents and notification of legal next-of-kin as soon as reasonably possible.

As a **PUBLIC HEALTH AGENCY**, the TCCOR provides information on the state of health of Tippecanoe County residents and alert the appropriate agencies of deaths that may present an immediate threat to its population. The TCCOR conducts epidemiological research and partners with multiple agencies to detect, investigate, and notify novel illnesses to better predict trends and support the at-risk populations.

# MONTHLY OVERVIEW OF CASES REPORTED AND INVESTIGATED

In September of 2021, **99 total deaths** were reported to the TCCOR. The TCCOR accepted, under its jurisdiction, **46 deaths for further investigation** this month alone. Since the beginning of 2021, the TCCOR has had **753 total deaths** reported to our office. Of these total reported deaths, the TCCOR has accepted, under its jurisdiction, **421 deaths for further investigation**.

## TCCOR September Caseload

Accepted Cases – The TCCOR has accepted, under its jurisdiction, **46 deaths for further investigation**.

Declined Cases – The TCCOR declined jurisdiction of **53 deaths**.

Autopsies – Of the 46 deaths accepted for further investigation, **25 were autopsied** to assist in determining the cause and manner of death.

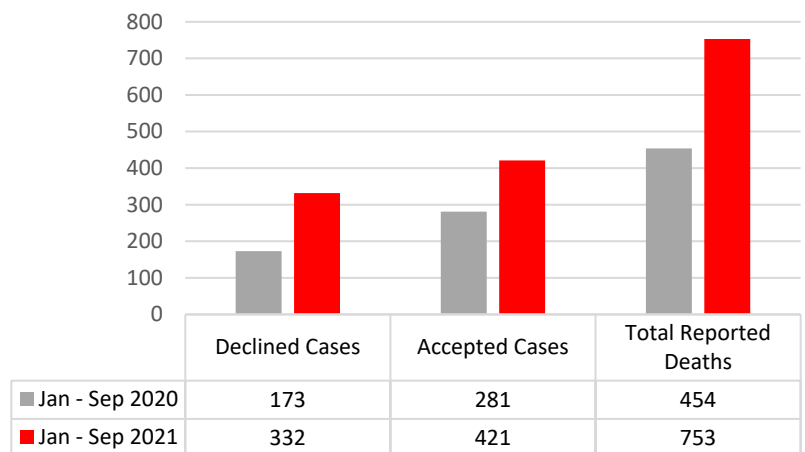
The total number of cases where jurisdiction was declined has **increased by 92%** compared to the same time last year.

The total number of cases accepted for further investigation has **increased by 50%** compared to the same time last year.

The total number of deaths reported has **increased by 69%** over the same time last year.

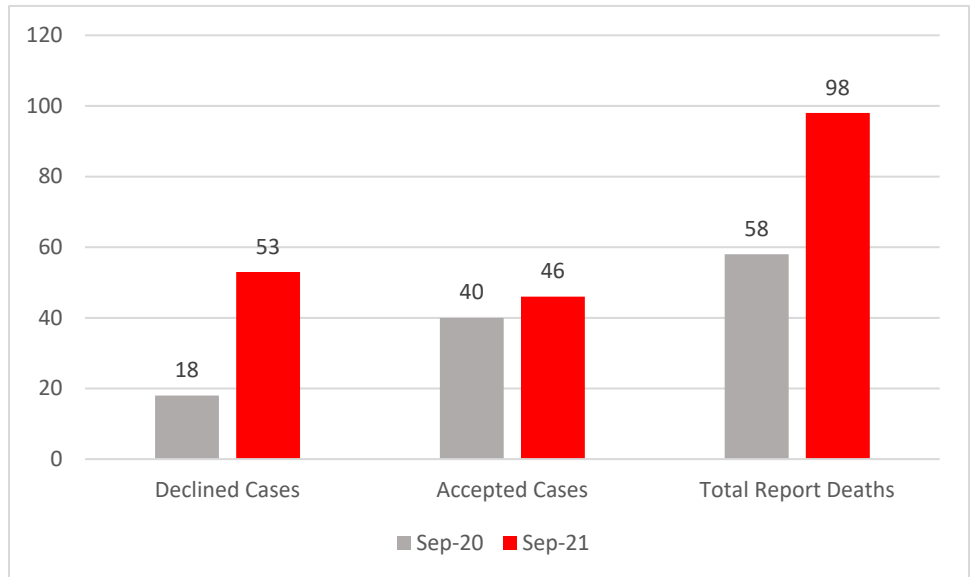
There was a **150% increase** in autopsies in September of 2021 compared to September of 2020. The increase in the number of autopsies performed is partly impacted by the increase in accepted cases.

### Comparison of Deaths for September 2020 vs. September 2021

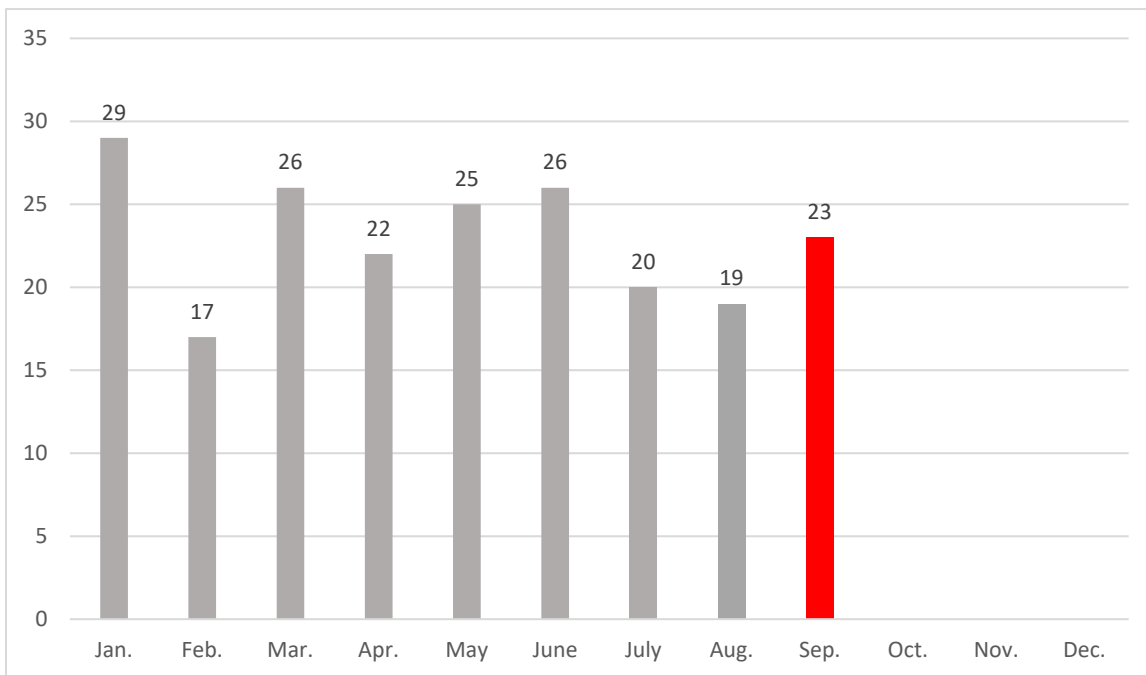
There is a **71% increase** in total deaths reported to the TCCOR in September 2021 compared to September 2020.

There is a **194% increase** in total declined cases in September 2021 compared to September 2020.

There is a **15% increase** in total accepted cases in September 2021 compared to September 2020.



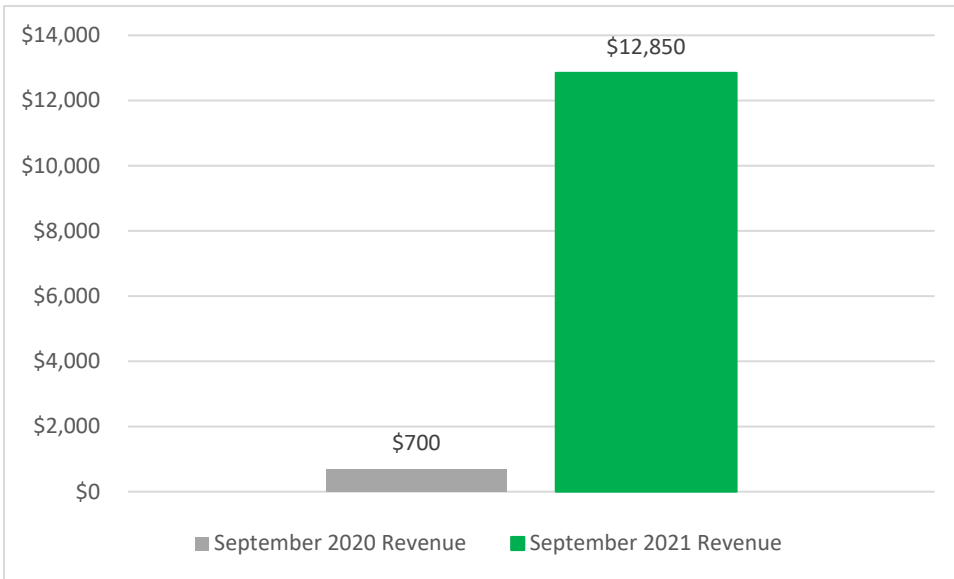
### Morgue Cooler Capacity



The morgue cooler was **at or above capacity for 207 days** out of the 272 days, or **76%** of the time, from the beginning of January to the end of September.

Since July 2020, the TCCOR has utilized a portable morgue for additional storage of decedents who are COVID-19 positive, decedents who have infectious communicable diseases that are a threat to the overall public health, and decedents who are not able to be placed in the inside morgue cooler due to limited space issues.

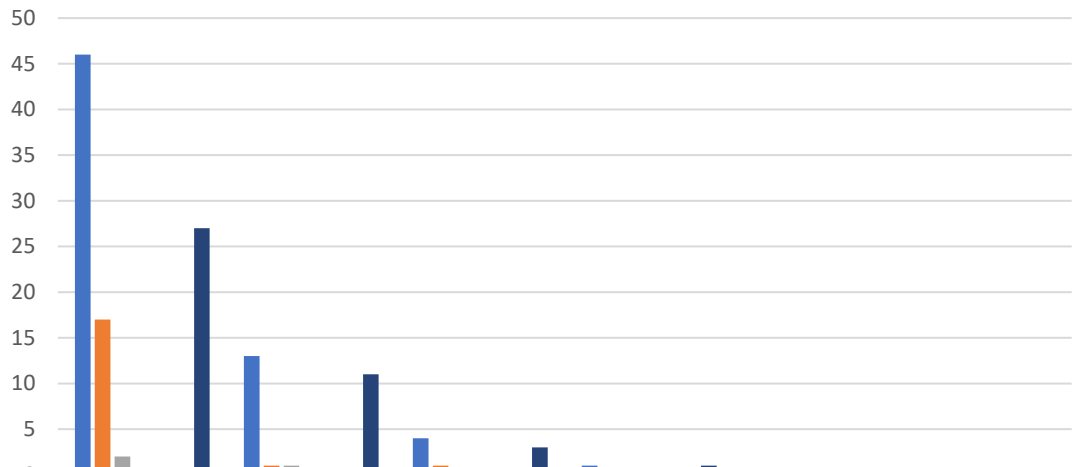
### Monthly Revenue Comparison



In September 2021, the TCCOR has generated \$12,850 in revenue that has been placed into the Tippecanoe County General Fund, compared to September 2020, in which only \$700 was generated. This is a 1736% increase.

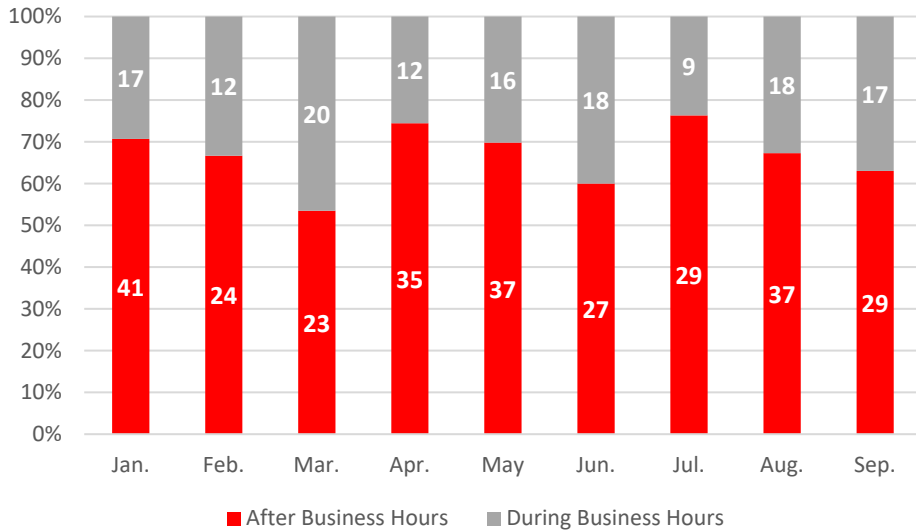

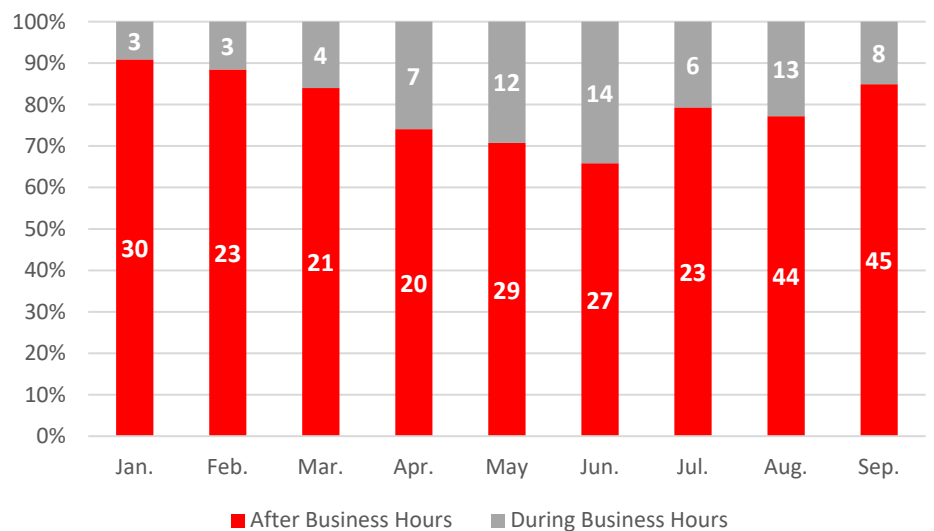
