Dear Board of County Commissioners:

Butler, Fairman and Seufert, Inc. (BF&S) is pleased to submit this annual On Call agreement for professional services. These services will apply to small, miscellaneous engineering projects where a formal contract is not appropriate.

BF&S will be assigned project on an on-call basis. BF&S shall submit individual Task Order for approval containing a short outline of services and a budgeted not to exceed fee. Task Orders will be approved by the Highway Engineer and then executed by both parties.

Compensation for services on Task Order projects will be based upon an hourly rate schedule using BF&S's standard rates calculated with our INDOT audited overhead of 158.3% plus a 15% profit. All time will be billed on a time and expense basis for actual time spent. A complete rate table for 2022 is attached. Expenses will be billed at Cost plus 0%. Outside Pass-through Services will be billed at Cost plus 0%.


BF&S shall comply with all requirements of the Americans with Disabilities Act and Title VI, as well as all applicable federal, state and local laws, rules, regulations and ordinances.

BF&S shall maintain \$1,000,000 in both Commercial General Liability and Automobile Liability Insurance, as well as \$1,000,000 in Professional Liability Insurance Coverage.

The attached Fee Schedule shall be effective upon County approval and shall apply to all work performed between January 1, 2022 and December 31, 2022.
