Compensation for professional services on Task Order projects will be based upon an hourly rate schedule using TBIRD's standard rates, to which you will find attached hereafter.


TBIRD shall comply with all requirements of the Americans with Disabilities Act and Title VI, as well as all applicable federal, state, and local laws, rules, regulations and ordinances.

TBIRD shall maintain \$1,000,000.00 in both Commercial General Liability and Automobile Liability Insurance, as well as \$1,000,000.00 in Professional Liability Insurance Coverage.

The attached Fee Schedule shall be effective upon County approval and shall apply to all work performed between January 1, 2022 through December 31, 2022.

- Overtime Rate shall be at a rate of 1.3 of hourly billing rate.
- Services performed specifically for legal proceedings (depositions, expert witness, related preparation of documents pertaining to professional opinions, and etc.) shall be multiplied by a factor of 1.5 times the above hourly billing rate.
