

**ORDINANCE NO. 2004-27-CM
OF TIPPECANOE COUNTY, INDIANA**

Be it ordained by the Board of Commissioners of the County of Tippecanoe that this Ordinance is adopted as follows:

1. Title. This Ordinance and all ordinances supplemental or amendatory hereto shall be known as the Tippecanoe County Health Department Fee Ordinance, and may be cited as such and will be referred to herein as "this Ordinance".

2. Purpose. The purpose of this Ordinance is to amend or otherwise establish fees for those services provided by the Tippecanoe County Health Department.

3. Enabling Legislation. Pursuant to I.C. 16-20-1-27 fees for services and records may be established by the Board of Commissioners and collected by local health departments.

4. Fees. Fees stated in prior ordinances of Tippecanoe County specifically stated hereafter are hereby confirmed, revised or established for services stated herein as follows:
