

ORDINANCE 2005-25-CM

AN ORDINANCE TO VACATE EASEMENTS IN THE
COUNTY OF TIPPECANOE, INDIANA

Be it ordained by the County Commissioners of Tippecanoe County, Indiana:

1. That the side yard utility and drainage easements located on Lot Numbered 198, key number 146-05315-0188, and Lot Numbered 199, key number 146-05315-0199 in The Retreat at Hickory Ridge Planned Development, City of Lafayette, Indiana, as shown on the plat recorded on November 4, 2004 in the Plat Cabinet 11, page 272 in the Office of Recorder of Tippecanoe County are hereby vacated and legal title thereto shall revert to the abutting landowner.

2. This Ordinance shall be in full force and effect from and after its passage.



ORDINANCE 2005 26-CM

**AN ORDINANCE REGULATING TRAFFIC CONTROL AT THE
INTERSECTION OF GOLDBERG DRIVE AND NORTH BROOKFIELD
DRIVE, IN BROOKFIELD HEIGHTS SUBDIVISION, IN TIPPECANOE
COUNTY**

WHEREAS, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the regulatory signs, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County Indiana, that the regulatory signs at the following intersection shall be established as follows:

- 1.) Two 30" High Intensity Stop Signs installed on Goldersgreen Drive at North Brookfield Drive.
- 2.) 4-Way Stop plaques installed on the existing Stop Signs on North Brookfield Drive, as well as on the new signs on Goldersgreen Drive.

The Sheriff's Department is to be notified of all the above traffic control installations.

IN ADDITION, MAY IT ALSO BE ENACTED BY THE BOARD OF COMMISSIONERS OF TIPPECANOE COUNTY, STATE OF INDIANA, THAT the effective date of this action shall be August 1st, 2005.

PENALTY FOR VIOLATION OF THIS ORDINANCE

A person who violates the regulation set forth in this Ordinance commits a Class C infraction.




