# FIXING THE COMPENSATION OF ALL COUNTY OFFICERS, DEPUTIES AND OTHER EMPLOYEES, AND FIXING THE NUMBER OF DEPUTIES AND OTHER EMPLOYEES FOR EACH COUNTY OFFICE, DEPARTMENT, COMMISSION, OR AGENCY
