

ORDINANCE NO. 2006-16-CM

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF TIPPECANOE COUNTY, INDIANA, TO REZONE CERTAIN REAL ESTATE, FROM A TO R1.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TIPPECANOE, INDIANA:

Section 1. The Unified Zoning Ordinance of Tippecanoe County, Indiana, being a separate ordinance and not part of a unified county code is hereby amended to rezone the following described real estate situated in Wabash Township, Tippecanoe County, Indiana, to wit:

The East Half of the Southeast Quarter of Section 25, Township 24 North, Range 5 West, in Wabash Township, Tippecanoe County, Indiana, being more particularly described as follows:

Beginning at a Berntsen monument marking the southeastern corner of the said Southeast Quarter; thence North 89° 42' 35" West along the southern line of the said Southeast Quarter for 1,321.61 feet to the southwestern corner of the said East Half; thence North 00° 33' 31" West along the western line of the said East Half for 2,644.84 feet to the northwestern corner of the said East Half; thence South 89° 43' 39" East along the northern line of the said Southeast Quarter for 1,315.19 feet to the northeastern corner of the said Southeast Quarter; thence South 00° 41' 52" East along the eastern line of the said Southeast Quarter for 2,645.35 feet; to the point of beginning, containing 80.05 acres, more or less.

EXCEPTING THEREFROM all of that part of the above described real estate which was rezoned from "A" to "R1" on December 4, 2000, by the Board of Commissioners of Tippecanoe County, Indiana;

CONTAINING AFTER SAID EXCEPTIONS a net area of 11.35 acres, more or less.


Section 2. The real estate described above should be and the same is hereby rezoned from A to R1.


