ORDINANCE NO. 2007- Z3CM AMENDING TIPPECANOE COUNTY CODE CHAPTER 72, SCHEDULES III & IV

Traffic Schedules regarding Stop and Yield Intersections

Traffic Investigation For Existing Yield Sign Intersection Control

May 2007

Tippecanoe County Highway Department

Introduction

Establishment of the proper level of traffic control on county roads can be problematic and presents challenges in selecting appropriate control for varying situations. Tippecanoe County Highway department uses guidance from the Indiana Manual on Uniform Traffic Control Devices (IMUTCD) as well as design publications from the American Association of State Highway and Transportation Officials (AASHTO).

Intersection Criteria

Yield sign locations listed in Schedule IV "Yield Intersections" found in the Traffic Code of the Tippecanoe County Code of Ordinances with total intersection approach traffic volumes of 150 vehicles per day (current average daily traffic) or a minimum of 400 vehicles per day on the major road were reviewed. Sight distance for yield control sight triangles was measured at each intersection based on speed limit and intersection geometrics (tee or 4-way intersection). Consideration was given for constrained situations where all legs of the intersection had an average daily traffic less than 400 vehicles based on AASHTO criteria for low volume roads.

Recommendations

Yield signs should be replaced with stop signs at locations where traffic volumes exceed 400 vehicles per day on the major road or locations where the total intersection approach volumes exceed 150 vehicles per day and there is insufficient sight distance based on a site investigation.

Locations

The following intersections should have the existing yield signs replaced with stop signs. The site location of the sign should be reviewed based on IMUTCD guidance and existing site geometrics for best sign placement.
