ORDINANCE NO. 2007- 37 -CL

PAYMENT OF PARKING FEES INCURRED BY JURORS

WHEREAS, IC 33-37-10-1 authorizes the Tippecanoe County Council, as the fiscal body of Tippecanoe County, Indiana, to adopt an Ordinance providing for the payment of parking fees incurred by jurors in lieu of paying jurors a mileage rate;

NOW, THEREFORE, BE IT ORDAINED by the County Council of Tippecanoe County, Indiana, that in lieu of paying jurors of Tippecanoe County Courts and members of grand juries an amount for mileage for travel to and from the court, Tippecanoe County shall provide for free parking for all such jurors at county expense in parking lots or garages designated for the use of jurors by the Board of Commissioners of Tippecanoe County.

This Ordinance shall be effective upon passage.
