AMENDING THE SCHEDULES OF COMPENSATION OF ALL COUNTY OFFICERS, DEPUTIES AND OTHER EMPLOYEES FOR 2007






WHEREAS, The County Council of Tippecanoe County, Indiana enacted Ordinance 2006-21-CL, fixing the compensation of all county officers, Deputies and other employees, and to fix the number of deputies and other employees for each county office, department, commission, or agency for calendar year 2007, all in accordance with Indiana Code 36-2-5-11; and

WHEREAS, The County Council desires to amend the Tippecanoe County Salary Schedules to adopt a schedule providing for a range of pay schedules for deputy prosecutors and to correct the PAT chart attached to Ordinance 2006-21-CL which failed to reflect an increase from 2005 rates.

NOW, THEREFORE, BE IT ORDAINED by the County Council of Tippecanoe County, Indiana, that the compensation of all county officers, Deputies and other employees, shall be fixed in the amounts set forth for each classification and grade of employment on the Amended Tippecanoe County Salary Schedules attached hereto and made a part hereof as **Exhibit A**.

This Ordinance shall be effective upon passage.


