

**ORDINANCE NO 2008- 12 -CM**  
**AMENDING TIPPECANOE COUNTY CODE**  
**REPEALING CHAPTER 34 SECTION 33**  
**ADDING NEW CHAPTER 34 SECTION 33**  
**FEE FOR ENHANCED ACCESS SERVICES**

**WHEREAS**, Indiana Code 5-14-3-3.6 authorizes public agencies to provide enhanced access to public records maintained by the public agency and to charge a reasonable fee therefore; and

**WHEREAS**, the Board of Commissioners of Tippecanoe County, pursuant to Ordinance CM-87 and Ordinance 95-55-CM, now codified as Tippecanoe County Code Chapter 34, Section 33 has authorized the Tippecanoe County Recorder to enter into agreements for enhanced access to public records maintained by the Tippecanoe County Recorder and to change a fee therefore; and

**WHEREAS**, THE Board of Commissioners has determined that the reasonable fee for enhanced access provided by the Tippecanoe County Recorder in the form of computer print-outs should be increased from \$.50 per page to \$1.00 per page.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of Tippecanoe County, Indiana, that the Tippecanoe County Code be amended to repeal Chapter 34 Section 33 and to add a new Chapter 34 Section 33 entitled "Fee for Enhanced Access Services" reading as follows:

**§ 34.33 FEE FOR ENHANCED ACCESS SERVICES.**

- (A) The County Recorder is authorized to enter into written agreements for the provision of enhanced access services at a rate of \$1.00 per page (one-sided, 8-1/2 by 14" or smaller) for all computer printouts.
- (B) All funds received by the Recorder in respect to such Enhanced Access Agreements shall be deposited in the Recorder's Records Perpetuation Fund.

This Ordinance shall be in full force and effect immediately upon its passage and signing.
