

**ORDINANCE NO. 2009-25-CL  
AMENDING TIPPECANOE COUNTY CODE**

**ADDING NEW SECTION 34.39**

**COMMUNITY CORRECTIONS DEPARTMENT  
JUVENILE ALTERNATIVES PROGRAM FEE SCHEDULE**

**WHEREAS**, Indiana Code 36-1-3-1 to 9, inclusive, grants certain home rule powers to Counties; and

**WHEREAS**, the Tippecanoe County Community Corrections Department's Juvenile Alternatives Program from time to time provides certain unique alternative services to juveniles referred by the Juvenile Court and local schools through the use of intervention, mediation, supervision, and education services. These services are provided to delinquent and non-delinquent minors in effort to improve behavior and deter progression through the juvenile justice system; and

**WHEREAS**, the Community Corrections Department desires to establish a uniform schedule of fees and charges for participation in such programs; and the Tippecanoe County Council desires to authorize the collection of such fees.

**NOW, THEREFORE, BE IT ORDAINED** by the Tippecanoe County Council, that the Tippecanoe County Code be amended to add a new Section 34.39 reading as follows:

**§ 34.39 JUVENILE ALTERNATIVES PROGRAM FEE SCHEDULE.**








The following fee schedule for is adopted for the Tippecanoe County Community Corrections Department's Juvenile Alternatives Programs:

Participation in the Tippecanoe County Community Corrections Department's Juvenile Alternatives FOCUS (Families of Children Under Supervision) Program for families identified by the court as being in need of group, individual and family therapy.	\$200.00
ART (Aggression Replacement Training) comprehensive intervention program designed to teach adolescents to understand and replace aggression and antisocial behavior with positive alternatives.	\$50.00
Juvenile Alternatives Parenting group: Staying Connected With Your Teen Curriculum	\$25.00


Girls Circle support group for girls.	\$25.00
Boys Council support group for young men.	\$25.00

This Ordinance shall be effective upon passage.








