HOME DETENTION INFORMATION SHEET

Check In:

Every Tuesday from either 8:00 am to 12:00 pm or 4:00 pm to 8:00 pm.

Check In is closed from Noon to 4:00pm

Bring your most recent check stub and your PBT tube to every check in.

Know your schedule when you come in and make sure it is filled out correctly as you will not be allowed to change it once it is made for the week.

Case Management:

When you come in for your scheduled CM meeting bring with you:

- Most recent pay check stub
- All Medications you have (current and expired)
- Completion certificates for any programming you completed or requested by your CM
- AA/NA Meeting log sheets
- Community Service Log Sheets
- Documentation that you attended Medical Treatment, Therapy, Substance Abuse Treatment, or any other appointment.

Passes:

Study Pass: Must be enrolled in school, 2 passes per week up to 2 hours each pass for School Studies Only, must be at school or library

Errand Time: 3 hours per week, can't be out past curfew, no travel time, not combined with any other pass, must be in Tippecanoe County. Fees must be under \$300.00 on check in day.

Church: 2 hours Once a week to include travel time, Tippecanoe County Only.

AA/NA Meeting: Based on Individual case plans.

Treatment/Therapy: Scheduled with start and end times.

Medical: Must get provide documentation on ALL medical passes

Earned Incentive Pass for Home Detention participants:

Must be on the program for at least 90 days, conduct free.

Curfew is 7 pm.

Must remain in Tippecanoe County

No travel time

Fees must be under \$300.00

Must have prior approval from your case manager

Holiday (Randomly selected):

Will be posted at TCCC a few weeks prior to the pass

Fees below \$100 will be awarded 3-hour pass

Fees below \$60 will be awarded 5-hour pass

Fees at \$0 will be awarded 8-hour pass
